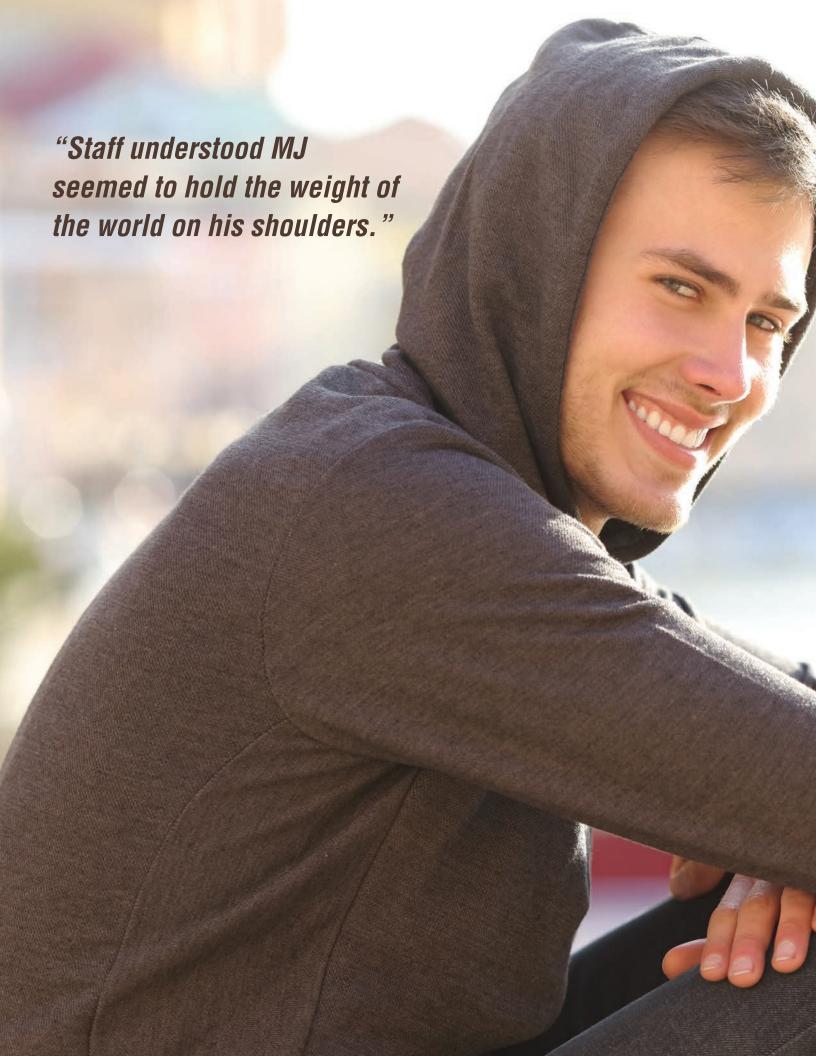

Fifteen year old MJ struggled from the moment he arrived. Overall, he was respectful and pleasant to be around, nonetheless, some days, it was harder to recognize these good qualities. Even though MJ often participated in disruptive incidents (many times he was the common denominator), staff continued to highlight his positives. This helped him understand that underneath his disruptive behaviors, we knew he had hopes, dreams, future aspirations. Yet, he desperately needed structure and accountability.

Staff understood MJ seemed to hold the weight of the world on his shoulders stemming from several untimely deaths of loved ones. Grief added to his struggle as he simultaneously tried to focus on his life goals, despite all the uncertainty in his life.

Although he was experiencing these hardships, he came to trust and utilize what he learned. He responded and flourished in response to staff's consistent overtures, finally trusting enough to open up in therapy. Pivotal in MJ's life was receiving our full menu of services, which facilitated his journey to growth and healing. Staff did not give up and MJ put in all the hard work. He successfully graduated from our STRTP program. We are glowingly proud of him!



Promesa operates a Transitional Housing Program for eligible youth aging out of the foster care system. We offer remote site options of fully furnished and home like, safe environments. Our effectiveness is evidenced by the requests of eligible, 'aging out' youth from our STRTP and Foster Care programs to remain in our care in the less restrictive environment of our THP-NMD program.

THP-NMD offers young adults the opportunity to supportively transition into adulthood, assistance with education, independent living skills, opportunities to obtain employment and support along with resources for their health, including their mental health.

#### In 2021:

40% of our "aging out" youth requested the continued supports that THP-NMD provides.

**50%** of THP-NMD participants report they are "better able to handle daily life" as a result of the supports received.

**72%** are 'on track' to finish post secondary objectives.

50% have secured employment.



Our substance use treatment department has provided the majority of our services via telehealth long before the pandemic so services were able to seamlessly transition to the virtual world. Our highly qualified, telehealth addiction counselors, facilitated recovery for client's receiving regular telehealth treatment.

"I like using the technology, so I don't have to stop working; I can see my counselor on my lunch."

### For adult clients:

79% expressed preference for telehealth as the means to receive services, while 21% preferred a more traditional face to face approach.

### For adolescent clients:

85% preferred telehealth as the means to receive services, while 15% preferred in person.

## EXPANDING OUR REACH

The pandemic made it clear that smart technology devices are the essential resources enabling us to sustain a seamless level of service. While still in the shadow of the pandemic, we developed a blend of virtual and site based services for all our essential programs. This approach qualified us to secure back-to-back funding to improve and expand our telehealth footprint.

The Center at Sierra Health Foundation on behalf of DHCS's Coronavirus Response and Relief Supplemental Appropriations Act Telehealth Expansion Project in 2020-21awarded \$100,000 for our Specialty Mental Health Services to provide virtual sessions to our youth; then again in late 2021, The Center provided an additional \$100,000 award to improve electronic resources for our Substance Use Disorder Treatment Services.

## These generous funds supported Promesa's upgrade to our telehealth infrastructure:

- · Adding to our capabilities to support virtual services
- Enabling us to offer intensive training for serving clients (youth and adults) with telehealth and virtual resources.
- Providing state-of-the-art encrypted devices to all Mental Health Program staff to facilitate their connection with our clients.
- Demonstrating outcomes that our adolescent and adult clients expressed a high level of satisfaction with our telehealth treatment options.

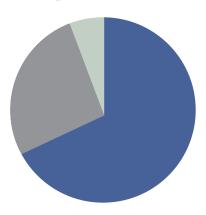


Promesa utilizes Specialty Mental Health Services Professionals, who provide direct services to 8 STRTP licensed programs.

Each program has an average of  $^2$  Mental Health Specialists assigned for on-site services. Youth receive an average of  $^3$ - $^5$  services per week, based on individual need.

Each youth has an opportunity to participate in an Experience Survey which attempts to gauge their perceptions of benefits, improvements needed, etc., with the mental health services they are receiving.

### 2021 Survey Responses: SMHS Services

Surveys use a likert type scale, which allows for degrees of opinion with relative ease of analysis. The refusal rate was low at 5%, 95% of youth gave complete answers to survey. Average age of responder 15.

### Here is what our youth have to say:

"Therapy helps me meet the terms of my probation"

"Counseling helps me sleep better"

"Peer Support would be a good thing"

"I like that staff is listening"

## **Staying & Course**

Maintaining focus on our mission and vision is what propels us to strive to maintain our purpose as a client centered organization. Using this as our compass, we make decisions surrounding the best needs of those we serve.

We believe and embrace the fundamental right of all children; that they be given the opportunity to thrive in a family they call their own.

### "I needed glasses, braces, I went to the doctor and stuff. They treated me like family and I got the things I needed."

With over 120 willing resource parents, we make every attempt to find children a home where they can best be themselves, feel safe and experience the security of a family. 50% of our children are in Intensive Services Foster Care (ISFC) meaning they require additional supports in their home life to help stabilize and heal trauma. We also provide additional guidance to our ISFC resource parents so that they may better meet the needs of the children they care for.

At the onset of the pandemic, personal protection backpacks, stocked with essential items, were given to each Social Worker. This ensured immediate accessibility to minimize exposure. Even though pandemic mandates have eased, we keep our compass pointed in the direction of rapid response.
